Please read carefully! Important information and dates contained in this Notice.

Dear Fellow Campers:

The Southeastern Conference Annual Camp Meeting is scheduled for **June 20-29, 2019**. It is now time to begin processing your registration for cabins and RV space rentals. We will be opening registration to regular and all other campers at this time.

Here are a few important reminders:

- All campers may only rent **one (1)** cabin per application.
- **CABIN OCCUPANCY LIMITS.** New cabin occupancy limits are as follows:

Cabins with Bathrooms (Maximum Occupancy 3 Persons):

1 Bunk Bed: Full Bottom (sleeps 2); Twin Top (sleeps 1);

Cabins without Bathrooms (Maximum Occupancy 4 Persons):

2 Twin Bunk Beds (sleeps 4)—1 person per bed

- **MOVE-IN DAY.** Wednesday, **June 19, 2019**, is the official move-in day for campers. **NO EXCEPTIONS. Moving in prior to this date, without prior authorization, will result in a charge of \$34.00 per day.**
- **EXCESS CHARGE.** Cabins must be rented in advance of arriving on the grounds; otherwise, **there will be an additional \$5.00 charge over the cabin price.**
- **AGE LIMIT.** No cabin will be rented to anyone under the age of 18.
- **REGISTRATION.** This year, we are offering two (2) options for registration: (1) the regular mail-in option and (2) online registration option.
 - **MAIL-IN OPTION.** Enclosed is the Registration Form which must be completed and returned with the required rental fees. Please read it carefully and complete **all** the information as requested, including the zip code for mailing purposes and area code for contacting you by telephone. The form and the deposit (or full payment) **must** be submitted at the same time, otherwise you risk losing the cabin/RV space you requested. **Please do not fax the form or e-mail it to us. The form must be returned by mail along with your payment.**
 - **Regular Campers.** Those who stayed in the same cabin for the last two (2) years consecutively, must mail the attached Registration Form to the SEC Office of Secretariat with your deposit by **April 1, 2019**. **After that date, the**

cabins will be made available to all other campers. NOTE: Full payment is due by **May 31, 2019**.

Other Campers. All other campers must complete and mail in the attached registration form to the SEC Office of Secretariat with your deposit by **April 1, 2019**. **NOTE:** Full payment is due by **May 31, 2019**.

- **ON-LINE OPTION.** The online registration option is available **to those who would like to pay for their registration in full.**
 - **Regular Campers.** Those who stayed in the same cabin **for the last two (2) years consecutively**, who would like to use this option please call the SEC Office of Secretariat (352-735-3142, Ext. 123) before **April 1, 2019** for **PRIORITY ACCESS**.
 - **Other Campers.** Online registration will be available after **April 15, 2019** for all other campers. If you want to use this option visit our SEC website at www.secsda.org. You may also complete the attached Registration Form and mail it to the Office of Secretariat along with your payment by **May 31, 2019**.
- **KEY DEPOSIT.** The key deposit amount is **\$25.00** and **is not included in your cabin rental cost.**
 - The key deposit must be paid **before** arriving on the camp ground.
 - Your key deposit will be refunded on the day of check out providing your cabin is in an approved condition.
- **SUBLEASING.** Southeastern Conference cabins are only rented through the Office of the Executive Secretary and **cannot** be subleased to other campers. Only the registered individual(s) will be permitted to sign-in at the front desk to receive the key.
- **POLICIES AND RULES.** All campers are subject to the policies and rules of the Southeastern Conference of Seventh-day Adventists.

DEPOSITS. The cabin rental requests are greater, as always, than the number of cabins available, and the requests are already coming in. So, we ask that you **send your deposit of \$100** for your cabin by **April 1, 2019**. The balance of your account must be paid in full (**NO EXCEPTIONS**) by **May 31, 2019**. Cabins will not be held without a deposit. **Kindly keep all deadlines in mind.**

PERSONAL CHECKS. Personal checks **will not** be accepted in the conference office **after May 31, 2019**. Also, they will **not** be accepted in the registration office on the campground.

REFUNDS. There will be **no refunds issued after May 31, 2019** for a cabin or a RV Space. Requests for refunds prior to **May 31, 2019** must be submitted in writing.

We are looking forward to hearing from you soon regarding your cabin and RV rental for Camp Meeting 2019. May God bless you as we look forward to a spirit-filled event.
